Sewerage & Water:

The RSM at the last meeting of the LA was authorised to liaise with PWC and NTEPA in relation to the sewerage and water quality within the community. Information was received back in relation to the leaking sewerage behind the Aged Care / Child Care facilities and the leakage between lots 16, 14 and 18 of which all had been repaired. She also advised that information was received in relation to the water quality but no information was received in relation to the audit of the pumps, the age of the infrastructure and the filtering of water at the bore.

Members advised that there are still ongoing issues with relation to sewerage. Lots 26 and 39 for example have strong smells from the sewerage and residents can not sit outside due to the smells and asked that the RSM following up on the infrastructure, pumps, etc. and report back to the next LA meeting
